

**MINUTES: September 2014 District Court Judge's Conference  
September 9, 2014**

The regular meeting of the District Judge's Conference was called to order on September 9, 2014. The meeting was held at the Little America Conference Center, Cheyenne, WY. Those in attendance included: Judges Brooks, Campbell, Cranfill, Day, Deegan, Donnell, Edelman, Fenn, Forgey, James, Lavery, Perry, Rogers, Rumpke, Sanderson, Sharpe, Skar, Tyler, Waldrip, Wilking, Young and retired Judge Price.

A motion was made and seconded to approve the minutes of the May 2014 meeting. Motion was unanimously adopted.

A motion was made and seconded to approve the Treasurer's Report and assess annual dues of [REDACTED] for a retirement gift for Joanne Odendahl. Motion was unanimously adopted. (Attached)

A proposed Report to Joint Judiciary Interim Committee was provided to the members of the conference. A motion was made and seconded to approve the submission of the Report to Joint Judiciary Interim Committee as drafted. Motion was unanimously adopted.

Judge Wilking provided an update on the case management and rules committee. There was discussion regarding the appropriate safeguarding of data available from the implementation of the WyUser case management software. No further action was taken.

A presentation of the retirement gift for Court Administrator Joanne Odendahl was made by Judge Cranfill.

Judge Sharp provided information regarding evidenced based sentencing and that data has been presented by the Dept. of Corrections indicating that while the volume of crime and type of crime has remained fairly level, incarceration has increased dramatically over the past approximate one and half decades. He indicated that proposals for evidenced based sentencing may be forth coming.

The conference discussed the ethical limitations of responding to anticipated questionnaires from the League of Women Voters or similar requests. The conference took no formal action rather deferring any action subsequent to actual receipt of any such requests.

Joanne Odendahl and Kristi Racines provided an update on the Court Interpreter Program. A list of registered interpreters is maintained by the Wyoming Supreme Court and available on its website. Training continues throughout the state and it was requested that a local district court judge participate in the presentation if possible. Any special assistance for interpreters including budget issues may be directed to Kristi Racines.

Joanne Odendahl provided an update on staff salaries. Most of the increase is available to bring law clerk compensation in par with other state agencies. Real time court reporter pay increase is available.

Presentation of the Wyoming Cowboy Youth Challenge and Riverton Job Corps programs was provided.

Steve Corsi, director of DFS, made a presentation regarding the background of legislative considerations of FINS versus the current CHINS statutes. It was reported that DFS did not see a need for any statutory modifications. He discussed the ongoing need to increase foster care placement options and other local placement options over Residential and Psychological Placement where appropriate.

Chief Justice Burke addressed the conference with a general expression to encourage additional local community involvement of the judiciary where appropriate.

Judge Tyler advised the conference of the revisions to W.R.Cr.P. Rules 32, 39, 41 regarding advisement of appellate rights which became effective Sept. 1, 2014.

The conference was advised of the modification of U.R.D.C. Rule 107 clarifying the authority of the District Court regarding security in the Courtroom.

It was reported that the BJPA passed a resolution requiring district court judges participate in local courthouse security commissions.

Judge Cranfill reported on the International Bias Conference held at the Heart Mountain Center near Cody, WY.

It was moved and seconded that the Chair could set the spring meeting outside of April at his discretion. Winter meeting will be held in Casper on December 11-12, 2014. The Spring meeting will be held in Cody with final dates to be determined by the Chair.

## REPORT TO JOINT JUDICIARY INTERIM COMMITTEE

To: Members of the Joint Judiciary Interim Committee

From: District Judges Conference

Hon. Steven Cranfill, Chair

Re: Annual Report

Authority: W.S. § 5-3-102(b)

The conference shall coordinate improvement efforts with the judicial administrative conference and shall report to the joint judiciary interim committee of such efforts annually on or before November 1.

### Rule 103(c), Rules Governing the Organization of the District Judges Conference

The Chair shall prepare and submit an annual report to the Conference at the September meeting in a form suitable for submission to the State Joint Judiciary Interim Committee. Once approved by the Conference, the Chair shall submit said report to the Joint Judiciary Interim Committee on or before November 1 of each year.

Over the course of the past year, the Conference has undertaken or partnered in several initiatives to improve the administration of justice in our general trial courts. Of particular interest are the following.

#### 1. Internal Rules

The District Judges Conference this year undertook to meet the following requirements of W.S. § 5-3-102(b):

The conference shall adopt rules, which shall be binding on all the district judges, governing the administration of the district courts to

(a) The district courts have the inherent authority to ensure that adequate courtroom security measures are in place. Every district court, following consultation with the sheriff, the local county court security management committee, and other interested stakeholders, shall determine appropriate security measures needed to protect courtrooms and court personnel. In devising appropriate security measures, the Wyoming Court Security Commission's Court Security Standards shall be consulted. The court may conduct appropriate proceedings and enter appropriate orders to ensure that adequate security measures are in place.

(b) Wyo.Stat. Ann. § 18-3-604 requires the Sheriff "shall attend all courts of record in his county." In consultation with the presiding judge, the sheriff shall provide a sufficient number of deputies to maintain order in the courtroom at all times. The rules and orders of the court pertaining to conduct in the courtroom shall be enforced by him or them.


The District Courts, as the general trial courts of the State of Wyoming, are ever mindful of their responsibility to protect members of the public who are involved in or attending court proceedings, together with court staff. The Conference understands there is a careful balance between security and maintaining a sense of open court. The District Courts intend to take the initiative, given the dictates of Rule 107, in assuring security in our public courtrooms.

### 3. Expedited Marriage Dissolution Cases

In some of our busier districts, there has been a chronic challenge to quickly process marriage dissolution cases. At the recommendation of the Board of Judicial Policy and Administration, the Supreme Court recently adopted Temporary Rules for Expedited Marriage Dissolution Cases. A number of judicial districts will voluntarily participate in employing these rules as a temporary pilot project. The Conference is excited to see what we learn from this innovative approach. It includes special treatment of cases involving self-represented (*pro se*) parties.
